THINGS YOU CAN DO IN THE ONLINE SYSTEM

- Submit your Application for New Certification.
- Submit payments for any required fees.
- Check the status of your application.
- Track the progress of your application.
- Upload documentation to your application.
- Withdraw your application (prior to submission).
 - Staff must withdraw if you've already submitted it to us.
- Update your name.
- Update your contact information.
- Print payment receipts.
- Print your application (i.e., application summary)
- Confirm documentation uploaded to your application.
- Obtain your Login Name.
- Reset your forgotten password.



COURT REPORTER CERTIFICATION OPTIONS



COURT REPORTER CERTIFICATION OPTIONS

1. Full Certification (i.e., Certified Shorthand Reporter, CSR).

This allows you to provide any services a certified shorthand reporter can provide without restrictions. This certification is valid for a maximum of 2 years. This certification can be renewed.

2. Certification by Endorsement (CSR).

This may allow you to become fully certified without passing the oral exam. This is considered a full certification; therefore, it allows you to provide any services a certified shorthand reporter can provide without restrictions. This certification is valid for a maximum of 2 years. This certification can be renewed.

3. Apprentice Certification (ACR)

This allows you to provide limited court reporter services (i.e., no court proceedings) and requires you to have a certified shorthand reporter as a supervisor. This certification is valid for a maximum of 2 years and cannot be renewed.

4. Provisional Certification (PCR).

This allows you to provide limited court reporter services in or out of court. This certification is valid for a maximum of 3 years and cannot be renewed.



MILITARY APPLICANT ELIGIBILITY REQUIREMENTS



MILITARY APPLICANT ELIGIBILITY REQUIREMENTS

- Eligible Military Applicants may be waived from paying the Initial Application fee and the exam fee.

Definitions per section 55.001 of Chapter 55 Occupations Code:

- **Military service member:** a person who is on active duty.
 - **Active Duty:** current full-time military service in the armed forces of the United States or active-duty military service as a member of the Texas military forces
 - **Military spouse:** a person who is married to a military service member.
 - **Military veteran:** a person who has served on active duty and who was discharged or released from active duty.
- **Military Applicants must meet one of the requirements below to be eligible for the fee waiver(s):**
 1. holds a current court reporter certification, registration, or license issued by another state that has requirements substantially equivalent to Texas requirements, **or**
 2. within the 5 years preceding the date of application, held a court reporter certification, registration or license in Texas.



COURT REPORTER CERTIFICATION REQUIREMENTS



CERTIFIED SHORTHAND REPORTER REQUIREMENTS

Requirements for a Certified Shorthand Reporter (i.e., a fully certified court reporter) are as follows:

1. Have a high school diploma or GED equivalent.
2. Submit the application for certification and pay the application fee.
3. Pass all part of the CSR exam. You must pass the oral exam portion in one sitting, not in legs.
 - You must not register for the exam prior to applying for certification with the JBCC. Applicants who register to test prior to applying for certification will not be permitted to sit for the exam.
 - Exam registration forms are **not** submitted to the JBCC. To register for the exam, you must apply with the exam vendor. Currently the vendor is the Texas Court Reporters Association(i.e., TCRA).
4. Pass a state (DPS) and national (FBI) background check.



CERTIFICATION BY ENDORSEMENT REQUIREMENTS

This option is not available for those with certifications held by an association, nor is it available to former Texas CSRs seeking to reinstate an expired certification.

1. Have a high school diploma or GED equivalent.
2. Submit the application for certification and pay the application fee.
3. Applicants must have passed their state's certification oral exam, or the NCRA's RPR (or greater) exam in one sitting and without using any audio backup. Passing in legs is not permitted.
4. Applicant's must currently be certified and in good standing with their state's licensing authority.
5. Submit all required documentation listed on the [Initial Certification page](#) of our website.
6. Pass the written knowledge exam.
 - You must not register for the exam prior to applying for certification with the JBCC. Applicants who register to test prior to applying for certification will not be permitted to sit for the exam.
 - Exam registration forms are **not** submitted to the JBCC. To register for the exam, you must apply with the exam vendor. Currently the vendor is the Texas Court Reporters Association(i.e., TCRA).
7. Pass a state (DPS) and national (FBI) background check.



APPRENTICE COURT REPORTER REQUIREMENTS

Apprentice court reporters may only be certified in the method of certification they've proven to be proficient in by their court reporting school.

1. Submit the application for apprentice certification and pay the application fee.
2. Submit the required documentation listed on the [Initial Certification page](#) of our website.
3. Have a currently certified shorthand reporter (CSR) supervisor.
4. Pass one leg of the oral exam as well as pass the written knowledge exam.
 - You must not register for the exam prior to applying for certification with the JBCC. Applicants who register to test prior to applying for certification will not be permitted to sit for the exam.
 - Exam registration forms are **not** submitted to the JBCC. To register for the exam, you must apply with the exam vendor. Currently the vendor is the Texas Court Reporters Association(i.e., TCRA).
5. Pass a state (DPS) and national (FBI) background check.



PROVISIONAL COURT REPORTER REQUIREMENTS

Provisional court reporters may only be certified in the method of which you were previously certified by Texas or your other jurisdiction.

1. Have been certified in Texas within 3 years of applying, been licensed in another jurisdiction and actively reporting for 3 out of the 5-year period immediately preceding the date of application, been actively reporting in federal court for 3 out of the 5-year period immediately preceding the date of application, or currently hold a certification in good standing issued by NCRA or another comparable or more stringent certification issued by NCRA or another comparable jurisdiction and been engaged in shorthand reporting 3 out of the 5-year period immediately preceding the date of application.
2. Submit the application for provisional certification and pay the application fee.
3. Submit the required documentation listed on the [Initial Certification page](#) of our website.
4. Have a currently certified shorthand reporter (CSR) supervisor.
5. Pass one leg of the oral exam as well as pass the written knowledge exam.
 - You must not register for the exam prior to applying for certification with the JBCC. Applicants who register to test prior to applying for certification will not be permitted to sit for the exam.
 - Exam registration forms are **not** submitted to the JBCC. To register for the exam, you must apply with the exam vendor. Currently the vendor is the Texas Court Reporters Association(i.e., TCRA).
6. Pass a state (DPS) and national (FBI) background check.
