LEGEND

Texas = click to view the defendant's complete Texas criminal history record

Other States = Click to view out-of-state criminal history by state (displayed within one tab per state)

Bond Conditions = Click to see current bond conditions.

Community Supervision = Click to determine whether the defendant is currently or has previously been subject to supervised release, including probation, parole, or other supervision programs.

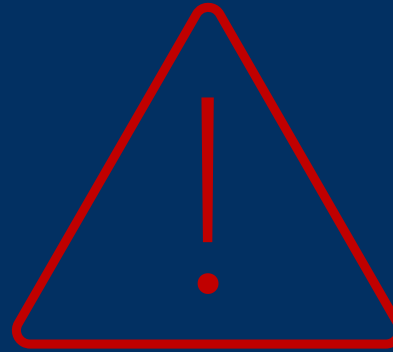
Failure to Appear = Click to a summary of willful failures to appear.

Pretrial Intervention = Click to determine if the defendant is participating in a Pretrial Intervention Program, and what the conditions are.

Protection Order = Click to determine if the defendant is a party to a protective order.

Wanted Person = Click to determine whether the defendant has any outstanding warrants, including out of state warrants.

Public Safety Report in the PSRS VS Public Safety Report Printed



Reviewing the PSR within PSRS ensures access to all available criminal history and supervision information at the time of decision-making.

Printed versions reflect only a portion of the criminal record.

- Bail Form must be certified in 48 hours
(reduced from 72 hours)
72.023(c)
- Ability to track 17.151 mandatory Releases
(enhancement driven)
- Memorialize no PC finding within 24 hours of Magistration.
HB – 15.17 (h)
- 30-day retention of criminal history in the PSR to support appeal process
44.01(f-2)

January 2026

- Prosecutors have PSRS access to view the Bail Form
17.021 (c-1)
- Mandatory Notifications
Cross-County – 17.021 (c-1)
District Attorney – 72.038 (c-1) Government Code
- Prosecutors must report PTI conditions
16.24
- API integration (OCA is actively working to provide additional information)
17.021 (h)
